3. Region 1 Summer Board Meeting Report

Adam shared the information from the meeting and will distribute the meeting minutes to the Board and the Association

- D. The Goal of Region 1 is to raise more money so we can send out Regional Select Team to an International Training Camp

Due to Adam Lomax accepting the position of Regional Chairman, it was necessary to rearrange the Southern California Board. After discussion, Matt Lowry agreed to take the position of State Chairman. 5. SCMGA Board Duties - Review

All duties were discussed. Some duties were changed...see attachement.

6. Web Portal Update

Matt Lowry has continued to work on and improve the Web Coaches will now have the opportunity to log in to view important information etc

7. 2017 State Championships Discussion

There was a discussion regarding the numbers of boys in each awards category in all levels.

Motion: If there are 40 or more boys within any SCMGA level and designated age group at State Championships, then they must be split by individual ages for individual awards only.

National Qualifying Levels and age groups will not be split for individual awards.

8. All Star Uniforms – Embroidery Issue

There was a discussion regarding the cost, style and future look of the All Star Uniforms.

Many felt that the current style of jacket is out dated and too expensive to produce.

Everyone agrees that the patches are a great idea but that iron-on patches might be better – Mitch Claman will investigate jacket styles and iron on patches.

It was decided that in the future jerseys and jackets will have a silk screened logo, not embroidered Everyone was in favor of investigating the possibility of using Turn Uniforms rather than GK.

Discussion followed about whether to begin change with younger or older athletes. No decision was made...shelved until next meeting to continue discussion

Mitch Claman, Sue Jacoby and Matt Lowry will work on ideas to be presented at next meeting.

9. Meet Bid Assignments

There was a discussion regarding the voting process used in the past to determine who would be awarded the SCMGA Meets throughout the year. Concern was expressed that everyone should be able to vote for all meets even if the gym they were affiliated with was bidding and that the votes regarding each meet should be recorded.

Motion: The SMCGA Board will vote for each bid submitted for each competition and record the results.

If there is only one bid for a particular competition, there will be no vote needed In the event of a tie, the State Director has the executive decision as to who receives the bid.

Motion: Sue Jacoby Second: Paul Sargsyan

The Board discussed all the bids for all the meets throughout the Competitive Season meet by meet discussing the pros and cons and calculating the best meet host for each meet.

A discussion followed regarding proposed changes in the meet bid sheet provided to gyms that are used to request meets. It would be helpful to have more information provided to us such as:

0-8-0

1. Size of Meet Location

2. Why bid submitted for a particular meet

- 3. Information regarding the Meet Director (experience, knowledge, etc)
- 4. If multiple bids are submitted they should be marked by priority.
- 5. If multiple bids are submitted how many would the gym actually be able or want to host.

Matt Lowry will look into amending the meet bid sheets to accommodate these recommendations.

10. SCMGA Club and Athlete Fees

The board discussed the pros and cons of increasing both club and athlete fees.

Motion: To increase the Athlete Fee to \$20 per athlete for the 2016-2017 Season

To increase the Club Fee to \$175 for the 2016-2017 Season to support SC United

Motion: Edmund O'Connor

Second: Dean Archie

PASSED: 8-0-0

11. Compulsory and FS Clinic Meet Host Fees

Fee will remain at \$60 per athlete.

Discussion regarding how the fee should be distributed between SCMGA and the Meet Host tabled until the Pre-State Board Meeting.

12. SCMGA Meet Entry Fee Increase

The Board has not raised SCMGA Meet Entry Fees in many years. It was discussed that the new USAG format of Division 1 & Division 2 will increase the cost of awards to Meet Hosts.

The idea of a Head Tax for Meets was discussed and decided against at this time.

Motion: Level 5-10 Athlete Meet fees will increase by \$5 for all SCMGA Sanctioned Meets

Level 4 Athlete Meet fees will increase by \$5 for Conference and State Sanctioned Meets

Motion: Kevin Fucella Second: Paul Sargsyan

PASSED: 8-0-0

13. JD Division & Division I/II Discussion

Matt Lowry explained the definition & requirements of the new Division I and II and JD as directed by USAG. He further recommended reading the Email from Lisa at USAG for more details.

- Division I Athletes are allowed to do bonus and will get bonus points. They are allowed to qualify to Regionals.
- Division II Athletes cannot do any bonus. They will not receive any bonus even if they attempt bonus. They cannot qualify to Regionals.
- "Junior Development" There are no levels in JD...only age groups (12-14) and (15-18)
 A JD Athlete must do 6 skills of any degree on each event.
 JD Athletes are allowed to go to Regionals but not Nationals

Discussion followed as to the timing of declaring whether an athlete was competing Division I or II and whether or not Level 4 would have Division I and II in the SCMGA Program

Motion: In SCMGA there will not be Division I and II for Level 4 Athletes

Motion: Mitch Claman Second: Dean Archie PASSED: 8-0-0

Motion: Meet Deadline is also the deadline for declaring Division I or II at any given competition.

Motion: Sue Jacoby Second: Dean Archie PASSED: 8-0-0

Motion: February 1 is the cut off for declaring athlete level and division for the 2016-2017 SCMGA Season.

Motion: Kevin Fucella Second: Sue Jacoby PASSED: 8-0-0

14. Level 4 Uniform Attire - Discussion

The Board discussed the Level 4 Clothing Attire Issue. It was agreed to leave the attire requirements as is. T-shirts are required but they should have sleeves. No determination was made as to the material allowed. Everyone has different preferences regarding fabric safety, looks, cost. It was discussed that Level 4 Uniforms should be uniform in style. The discussion was tabled until the Pre-State Board Meeting.

15. Level 4 Handstand Contest - Discussion

The Board discussed the Level 4 Handstand Concept for Level 4 (Pros and Cons)

The discussion revolved around the fact that most Level 4 Boys cannot hold handstands for any amount of time so we need to discuss ways to make the contest and title more meaningful. Some thoughts were:

- a) Drop the Mr. Handstand Contest for Level 4 Athletes
- b) Allow "walking"
- c) Change the contest to "Press Headstand"
- d) Have Clubs determine their Level 4 Handstand Champ and have those boys compete at State
- e) Only have all boys participate in a "Mr. Handstand" competition at State

Matt asked that all Board Members send their ideas to him and he will prepare a survey for all Clubs to consider.

16. 2016-2017 Budget and Financial Report

Presented by Matt Lowry. SCMGA is in good fiscal shape.

17. Other Business

A. It was noted that Level 4 will not be using the Pommel Horse in the new Quadrenium.
